- 3) Served at the district level in District 49 at least two additional full years than what is required for DTM. One of the following qualify:
 - a. Member of the District Executive Committee
 - b. Committee Chairperson appointed by the District Director/District Governor
 - c. Served as District Parliamentarian or Webmaster
- 4) Hawaii resident

Nomination period is April 22, 2025 to April 29, 2025.

This award will be presented at District 49 Annual Conference on Saturday, May 3, 2025.

Individuals who have completed the certification requirements more than once only need to document one of each level of certification to be eligible. Additional certificate registrations, District positions, Club memberships, and presentations should be listed on a separate sheet.
